About **PRAJWALA**

Prajwala is a pioneering Indian anti-trafficking organization based out of Hyderabad. Focused on ending trafficking for the purposes of commercial sexual exploitation/sex trafficking, the organization has also done significant work to challenge sex crimes against women and children.

Founded in the year 1996 by two visionaries Sunitha Krishnan (Padmashree Awardee) and Late. Bro. Jose Vetticatil in response to the eviction of a traditional red-light area in Hyderabad, the organization's first response was to set up an education program for the vulnerable children of women in prostitution as a means of second-generation prevention.

Over the years the organization has evolved comprehensive program addressing prevention, rescue, rehabilitation, reintegration and advocacy. Many innovative interventions designed by the organization including safe homes providing holistic rehabilitation, demand reduction campaign 'Men against Demand', community awakening campaign 'Swaraksha', one stop crises centers for entry/exit intervention, training manuals on victim centred investigation and home management has become best practice programs in the world.

Prajwala's path-breaking legal advocacy has led to Government of India drafting the first ever comprehensive legislation to combat trafficking in persons. The historic Bill is set to be introduced in the parliament in the coming session. The organization also has been responsible for the cybercrime portal of the country to report cases of videos of rape/ gang rape and child sexually abusive material.

After successfully rescuing over 24,500 women & children from sex slavery and rehabilitating 22,000, Prajwala is considered as a path-breaking organization in the anti-trafficking sector becoming the voice of the millions still enslaved and paving the way for alternatives and responses to end this modern-day slavery.

MESSAGE FROM THE GOVERNING BODY

All the shelters in spite of Covid fear continued to operate, rescue team continued to assist the police in removing victims from places of exploitation, legal assistance was extended to all victims, repatriation of foreign nationals continued and most importantly the ‘new normal’ of using virtual space was fully utilized to reach out to the community. Very few organizations can boast of releasing 15 Handbooks for stakeholders in three states of Odisha, Andhra Pradesh and Telangana at the peak of pandemic. Prajwala has proved without doubt integrity in mission and determination against all odds can surpass any mountain.

Proud to have initiated this mission 25years back...proud to be supported by an amazing Governing Body that believes and supports this passion...proud to walk beside a extraordinary courageous group of human beings who constitute Team Prajwala!

I am happy that the team is working hard and we wish, hope and pray that we get out of this situation soonest.






JOURNEY SO FAR

Prajwala has come a very long way in providing services for prevention and rehabilitation of women and children rescued from commercial sexual exploitation. During the financial year 2020-2021, a team of 232 committed staff both professional and field workers have been managing all interventions of Prajwala, 50% of whom are survivors themselves. The rest of the team comprised of committed professionals from all walks of life including individuals with post-graduate degrees in management and social work. It is the dedication and commitment of this team that makes Prajwala a successful need-based organization. Prajwala has a small percentage of very committed volunteers who have dedicated their skills for this mission.

PRAJWALA'S INTERVENTIONS

Prajwala has evolved over the last 25 years a comprehensive set of interventions that aims to address sex trafficking and sex crimes in a holistic manner. It is perhaps one of the few pioneering organizations in the world that has addressed the issue from all ends with considerable success ranging from prevention, rescue, rehabilitation, restoration and reintegration.

From a programmatic perspective, Prajwala believes in experimenting different approaches to tackle the problem, evolve evidence based solutions and advocate with state and non-state partners to replicate or adapt it.



PREVENTION

An organized crime such as human trafficking has to be prevented at any cost. The collateral damage to the communities is irreversible threatening the very core of right to life and liberty. From its inception the organization has taken all efforts to prevent human trafficking through various strategies. The overall strategies can be classified as:

Prevention Through Vocationalized Education Program

Community Based Prevention Program

I. PREVENTION THROUGH VOCATIONALIZED EDUCATION PROGRAM

The Prevention Through Education Program (PTEP) aims to prevent trafficking using education as a tool. The intervention identifies vulnerable communities where there is high risk of human trafficking and sets up 'Learning Centers' which supports a child to integrate into mainstream education and employment system. The parameters used to identify vulnerable communities have been evolved in consultation with women in prostitution who are also members of the Mother's Committee. These women identify areas which has several such women residing in anonymity. The children of women in prostitution are given highest priority followed by orphan and semi-orphan who are economically and emotionally vulnerable.

The Learning Center comprises of three units. The Education Center which provides bridge education to children between 10-14yrs, Open School that provides education to school dropouts above 14yrs and Vocational Center that provides vocational training to anybody above 14years.

There are seven Learning Centers including one residentially located in the Children's Home catering to child victims of sex trafficking and sex crime.

HIGHLIGHTS OF THE YEAR

The academic year started with much chaos and uncertainty due to the Covid Pandemic. With multiple lockdowns from April 2021 till end of June 2021 all educational institutions were closed down and the Learning Centres were no exception. The plight of already poor and vulnerable communities worsened during lockdown with massive economic devastation and mass-scale distress reverse migration. The children in these communities disproportionately bore the brunt of this situation making them more at risk to be trafficked for labour exploitation or commercial sexual exploitation as families looked at options to survive. The need to get back children in the educational fold became imperative. The challenge of technological deprivation with most children not having any access to smart phones or laptops ruled out the possibility of online classes. The capacities of the teachers to use the virtual medium was also limited as most teachers are identified from the communities itself. The following efforts were taken to ensure that all children were prevented from induced into any form of exploitation.

1. Building Capacities of the team

The first three months April, May and June was dedicated to building the capacities of the teachers to handle the Covid Crises and also evolve appropriate solutions to ensure safety of the children in communities.

In collaboration with Silver Oaks International School all the teachers were trained in methods to prepare videos. The training focussed on how to handle sessions in a virtual space and make it interesting for the children.

During the same period the team was also trained in using the social media by practical exercises and preparing lesson plans in the virtual mode. The teachers learnt through practical sessions the use of skype, zoom, google meet and whatsapp groups.

2. Education Centres and Open School

During the lockdown the phone numbers of all children who had smart phones in the family was collected and Whatsapp groups were set up. As per the curriculum/syllabus and the lesson plans short videos with worksheets were prepared which was sent on the whatsapp group to children belonging to various levels. The children completed the worksheets and would send back using the same Whatsapp group. While 70% of the children were covered under this effort 30% did not even have access to a smart phone. For those children the teachers came to the school and conducted classes in small batches of five.

While the Government took a decision to close all educational institutions for the academic year due to the pandemic, taking into consideration the immense risk to the life of a child if she/he remains out of school the organization took the decision to reopen all the Learning Centers from October, 2020. The situation in the communities was grim with the dual impact of the pandemic and the floods. Many families fled to their home towns fearing economic backlash. Hence all efforts were focussed to ensure that the ones remaining back in the communities continued to be access to education and are coerced into exploitative situations. New children were enrolled based on each community's specific situation. Over 459 home visits were made to ensure all children were in the safety net of the center.

3. Vocational Center

Every Learning Center has a Vocational training cum production unit that provides livelihood training to anybody above the age of 16years. The trades are locally selected based on viability and sustainability. Cultural sensitivity is also maintained as most communities where the Learning Center is located are dominated by Muslim population. The strategy adopted is to give vocational training and also introduce the trainee to job market during the course of training. All the centers except that one located in the safe shelter complex has a production/service unit. Income from these units directly goes to the trainee. The three trades currently in the centers are:

- Mobile Repairing
- Jute Bags Making
- Tailoring

289 trainees were trained of which 122 gained meaningful employment during the training period. A sum of 3,21,362 INR was generated as income for the trainees at the vocational unit this year.

4. Community Participation/ Mother's Committee

Participation and ownership of the community is at the core of all Learning Centers. The mother's involvement in the management of the 'learning centers' is critical in the effective functioning of all the centers. The mothers are involved in identification of beneficiaries, monitoring the center and mobilizing resource support.

5. Baseline Survey

Due to Covid Pandemic there was large scale reverse migration. Fear of virus and breakdown of livelihood forced thousands of migrants to rush back to their home towns. The communities where the centres are located are inhabited by a large migrant section most of whom fled to their home towns. The pandemic created a new set of vulnerable population whose lives and livelihood were completely destroyed. To understand the new role of the Learning Centre a "baseline survey" was conducted to identify 'at risk' children which included orphans, semi-orphans or children from difficult circumstances(broken family, mother in prostitution, differently-abled parents) . The entire survey was conducted by teachers/trainers with the support of mothers committee in their respective communities. A survey format was evolved and all risk factors were

taken into consideration before the survey was conducted. The secondary information was gathered from Municipal Office and frontline workers such as Asha Workers and Anganwadi workers.

6. Scrutiny Committee

To foster community partnership and community ownership each Learning Center set up a Scrutiny Committee comprising of the local police officer, frontline workers from Health and Women & Child Welfare Departments known as Asha Worker and Anganwadi Worker and two representatives from the mother's committee. From this year onwards the admission process which was largely centralized was de-centralised and the scrutiny committee became the recommending body for any admission. The recommendations requests will be placed by the centre in-charge based on the Baseline Survey which would be independently verified by the committee and recommended for admission. The Committee would meet every quarter for the purposes of enrolment. In this year one meeting of the scrutiny committee was held and 187 children were approved for admission.


7. Covid Relief

As the Covid Pandemic hit the entire nation, each of the communities where the Learning Centres were also located was also impacted. Each centre team decided to mobilize their own resources to support the local community with dry groceries. As a first step each of the staff contributed for the groceries of five families. Additionally each staff also stitched 25 reusable masks which was distributed in the community. The team also took part in the Covid Relief Work targeting fleeing migrant workers and transgenders organized by the management.

8. Flood Relief

The year 2020-2021 was a double jeopardy for most communities in Hyderabad with Covid Pandemic and floods hitting at the same time. Most of the learning centres located in low lying areas were submerged and a majority of the centres were subjected to massive damage. A committee was set up within the organization to assess the damages. The hunger and starvation in the community compelled the organization to provide groceries to all the community. In some places financial support was also extended as an immediate relief. The Learning Centre Teams were involved in both flood relief work and also restoring their own centres from the wreckage caused by the flood.

II. COMMUNITY BASED PREVENTION PROGRAM

Community Based Prevention Program (CBPP) is engaged in preventing sex trafficking through mass sensitization programs, campaigns and rallies to awaken the community to end the supply and dedicated efforts to reduce demand for prostitution. The team partners with local community members, police department officials and district administration to raise awareness about sexual crimes and sexual slavery. It also empowers individuals to take ownership of their local community to become more responsible, informed and vigilant citizens through formation of Community Vigilance Groups (CVGs).

This year, despite the challenges caused by Covid-19 pandemic and the lockdown, the team managed to conduct multiple sessions for important stakeholders like students, men and anganwadi teachers. Additionally, CVG members were responsible for stopping 16 child marriages in the states of Andhra Pradesh and Telangana.

HIGHLIGHTS OF THE YEAR

1. Programs for Anganwadi teachers

Anganwadi teachers can play a very important role as they have close access to young children adolescent girls. This year, thousands of Anganwadi teachers were made aware of the laws and acts of human trafficking both online and offline. Further, on follow up with previously trained Anaganwadi teachers, we found out that **118 members** conducted awareness programs to adolescent girls and women on the issue of human trafficking this year. Government Departments like the Anti-Human trafficking Unit, Vikarabad, Sakhi One Stop Center, Vikrabad and District Legal Service Authority, Nalgonda also contributed proactively to the Anganwadi Teacher trainings.

2. Programs targeting students

Students studying in Government schools and colleges come from the lowest strata of the society. Most of them are first generation learners and are for the first time stepping out of their homes to get exposed to the outside world. The chances of luring or trapping them into an exploitative situation is very high. The programs conducted in schools focus on cases involving love, film roles and modelling which are the common baits used to trap young students from schools and colleges. The initial program is followed by identifying students for school/college vigilance and thereafter training them to take up vigilance activities. Due to the Covid Pandemic educational institutions were closed for the this academic year in spite of the same a few programs were organized when for a few weeks lockdown was relaxed and schools were reopened briefly.

3. Demand Reduction

Men and boys who buy sex constitute the ‘demand’ for prostitution. The need for paid sex is fuelled by pornography and women being shown as sexual objects by mainstream media. While most efforts to prevent human trafficking and in particular sex trafficking has largely focused on the supply front targeting vulnerable women and girls a holistic approach to prevention will be to also address the demand. Men and boys are targeted through schools, boys’ hostels, employee unions and trade unions.

4. Online Series

Responding to the situation and the limitations, decision was taken to adopt alternative methods to fulfill the same objectives. A strategic virtual series was planned with survivors of trafficking and key stakeholders such as judicial officers, prosecuting officers, legal advocates, police officers and parliamentarians. Titled **#RealityCheck** as a **#EndHumanTrafficking Series** the online episodes were held every Friday for two months completing 6-episode series with one more extra inaugural episode on 30th July,2020- World Day Against Trafficking in Person. The online conversation held on zoom was live on Facebook reaching out to thousands of public. The zoom corner had 200-500 participants every week. Eminent panelist from across the country including Former Supreme Court Judge, legal luminaries and dynamic police officers participated in the virtual series. A total of **38,813** were reached out and sensitized through the virtual engagement.

Media Coverage

RESCUE

Rescue is the removal of a victim from an exploitative situation. The Prajwala Rescue & Restoration Team assists victims during a rescue and thereafter for the entire legal process until they are restored and reintegrated back into the society making the entire intervention more victim-centric.

The initiatives of this team are as follows:

1. Rescue and Restoration Program
2. Rape Victim Support Program
3. Vikalpa Crises Counselling Centre/Sex Offenders Support Program

I. RESCUE AND RESTORATION PROGRAM

Every day millions of women become victims of trafficking. These victims are subjected to endless cruelty by traffickers, pimps and customers. This results in not only physical harm, but also a lot of emotional trauma. Survivors of trafficking often suffer lifelong consequences due to the physical and mental trauma such as anxiety, panic attacks, attachment disorder, depression, substance abuse, attention deficit hyperactivity disorder (ADHD), tendency to self-harm, eating disorders etc. Post-traumatic stress disorder is one of the most common disorders found among the trafficked victims.

For the process of rescue, restoration and protection of the victims, the Rescue and Restoration Team primary assists the police in rescue of victims and also provides an array of services such as legal support/aid, victim witness assistance, recovery of victim's belongings, support during trial and support for restoration and rehabilitation.

HIGHLIGHTS OF THE YEAR

Due to the Covide-19 pandemic and the resultant lock down, there were a lot of unprecedented challenges and most of the work and legal issues had to be dealt virtually. This practically changed the way the team operated as the local legal counsel was the only person who could engage with the courts. In pre-pandemic times the team was used to approaching the judicial officer directly but post-pandemic as the court proceedings were all virtual only the legal counsel could file petitions.

A total of 279 victims were rescued during the Covid pandemic of which 13 are minors and 32 are foreign nationals.

However, the team still managed to take the following steps towards the rescue and rehabilitation of the victims:

1. International Rescue Operations

The team assisted in the rescue of 32 victims belonging to Nepal, Bangladeshi and Uganda from different parts of the city and facilitated their rehabilitation through the safe shelters operated by the organization.

2. Collection of Information Regarding Traffickers

As most victims are hostile and suffer from serious trust deficit, trained survivors who are part of the team provide the victim peer counselling which slowly build trust in the victims. The team thereafter collects information of traffickers, solicitors and others involved in sex trafficking crimes through interactions with victims. This data was then handed over to the National

Investigation Agency, CID or Police departments who take action against the traffickers based on information provided. Information from 18 new victims lead to the arrest 30 more traffickers.

3. Assisting Courts in Home Investigation Report (HIR)

The team assisted local courts in conducting **172 Home Investigation Reports** as per **Sec 17** of ITPA. The home investigations were conducted pan India and in Bangladesh and Nepal. A significant number of investigations were conducted virtually through the support of partner NGOs.

4. Victim Grievance Redressal Mechanism

Every victim who is admitted in Prajwala is provided access to express her grievance and seek redressal. Any grievance related to police stations and court is directed to Rescue Team. Most of the grievances are related to recovering of personal belongings which is in police custody, conducting an enquiry into the family's status or applying for self-petition in the court. A total of **177 grievances** were resolved successfully by the team.

5. Family Reintegration

A legal entity such as the Court or the Child Welfare Committee is the only authorized body to direct the release of a survivor from the shelter. The Rescue & Restoration Team have the responsibility to hand over the survivor to the family after due diligence, submit the exit papers to the Court/CWC and follow up the survivor. This year as per court orders, **200 survivors** were reintegrated to their families. As per the organization's protocol all the survivors were followed up on regular basis. As per the follow up reports **91 survivors** were supported with monthly groceries during Covid lockdown phase.

6. Repatriation

The process of international repatriation starts with a court order. This is preceded by a nationality verification with the support of a International Partner in that country. The court order with the nationality verification is then forwarded to the concerned High Commission/ Embassy for temporary travel permit. Finally all the requisite papers are handed to Foreign Regional Registration Office for facilitation of the 'Exit Permit' and repatriation.

This year 31 foreign nationals were safely repatriated to their country of origin. The team worked closely with International Partners Maiti Nepal, Justice & Care, Rights Jessore and Bangladesh Women Lawyers Network. Foreign nationals from Nepal and Bangladesh were safely restored to their country.

II. RAPE VICTIM SUPPORT PROGRAM

This intervention aims to provide supportive services to child victims of rape/sexual assault. The team reaches out to the family of all reported cases of child rape in Andhra Pradesh and Telangana within 48hours of the case being reported and extends all support to fight legally and also access the existing Government support system for interim relief and rehabilitation. In case of a threat perception to the life of the child, she is provided safe shelter and protection.

All support is provided to the child in the shelter which includes:

- Victim witness assistance
- Interim Relief
- Compensation
- Civic Identification- Aadhar Card, Bank Account
- Social Reintegration

HIGHLIGHTS OF THE YEAR

This year a total of 39 child victim were reached out based on various news reports. Of them 19 were found to be children under grave threat from the perpetrators and were admitted to the safe shelter on the directions of the Child Welfare Committee.

The team visited all the concerned police stations, interacted with the families providing them all information regarding the legal rights of the child and made a risk assessment of the threat perception.

1. Victim Witness Assistance

Conviction in a case of sex crime is only possible when the victim is supported and protected during the long and lengthy legal battle. Victim witness assistance includes supporting the victim in her legal fight by escorting her to the court, supporting her to identify the perpetrators, giving necessary assistance to testify and face the trail.

A special team went to Badrachalam to provide counselling and support to families of five child victims. In one case DNA test was arranged at TRFSL – Telangana Regional Forensic laboratory.

This year 17 children testified with conviction not less than 10 years Rigorous Imprisonment in 10 cases with fines.

2. Interim Relief & Compensation

The fight for justice is also about damages a victim faces due to the violation and the State support she receives. Any child victim is entitled to interim relief from the Department of Women & Child Welfare and compensation from the court for the damages.

Due to the pandemic the awarding of interim relief and compensation was delayed. While 23 victims applied for relief and compensation only one of them received it.

One victim received of Three Lakhs compensation from District Legal Services Authority in Cr.no 477/2016 with two lakhs being deposited in a fixed deposit.

3. Family reintegration

The confidence of a child survivor to face the society and reintegrate with the family is achieved

after two or three years of support which includes safe shelter, psychological counselling, health care and educational support.

This year 13 children were successfully reintegrated with their families.

III. VIKALPA CRISES COUNSELLING CENTER

As an entry/exit strategy to curb street prostitution and reduce demand Vikalpa Crises Counseling Centre was established in collaboration with the Hyderabad City Police.

At present, Vikalpa Center operates in the North zone and has successfully been able to eradicate street prostitution in and around Secunderabad Railway Station with active collaboration from the Hyderabad Police Department under Mr. Kalmeshwar Singhwanwar, the current North Zone DCP Hyderabad Police is divided into 4 police zones -North, South, East, West and Central for smoother functioning.

While the main aim of Vikalpa is to change the mindset of woman in prostitution by behaviour modification and also reduce demand, this year the entire focus has been on 'demand reduction' by counselling sex buyers.

The sex buyers apprehended by the police are brought to the counselling centre and thereafter a three pronged approach is followed:

- Professional counselling by trained counsellors
- Counselling by Family Members
- Counselling by Faith Leaders

The impact of the intervention is felt in zero recidivism.

HIGHLIGHTS OF THE YEAR

- Street prostitution has been curbed in North zone.
- 33 sex buyers were caught, counselled and handed over to police stations for appropriate action to be taken.
- A total of 20 petty cases were registered against sex offenders at 3 zonal police stations.
- A total of 20 sex buyers were convicted with fine.
- The centre coordinated with railway police, Child line and NGOs to gather information related to minor victims and traffickers.
- A follow up was done to find out the current status of victims and solicitors from 2016 to 2020.
- Information regarding online prostitution was collected.
- 1 decoy operation at was conducted in Secunderabad Area.

REHABILITATION AND RESTORATION

A range of therapeutic services are provided through the various shelters run by the organization.

These homes serve to heal and build trust, hope and self-esteem through its various programs. The Protective Homes managed by the organization include:

1. Emergency Shelter
2. Children's Home
3. Adult Shelter
4. Co-Managed Shelter-Hyd
5. Co-Managed Shelter-Vijayawada

The homes provide a holistic rehabilitation through psychological healing, educational/vocational/ economic empowerment and restoration of civic identity.

The various homes as per the needs of the residents have customized programs.

The Emergency Shelter is a transit home that provides temporary support to the victim in terms of first response medical care, legal support, basic life-skills and employability training. The victim thereafter is shifted to the age appropriate shelter.

The Children's Home provides all support to the child victims motivating them for education. The home has in-house education centre and an open school. The children are admitted to mainstream schools and colleges based on the threat perception in their lives. There is also an Aftercare facility to help support children who have attained 18 years or above whose family do not want to support they can stay and pursue education or job opportunities outside.

The Adult Shelter provides a range of crafts as life-skills and motivates the women to take up vocational trades as per their aptitude. The Economic Rehabilitation program consists of Employability Training and Training in Book-Binding, Screen Printing, Welding and Carpentry.

The Co-managed shelters are run in collaboration with the respective Governments and follow all the protocols of the Adult Shelter.

Additionally, there are 2 co-managed homes which are partnered with the AP and Telangana State Governments at Kukatpally and Vijayawada.

SURVIVOR ADVOCACY PANEL



The Survivor Advocacy Forum was established with the objective to advocate survivor's rights and cater to survivors' grievances and issues. The survivor committee with a 5-member core committee panel selected among the survivors lead and monitor all activities of the forum.

The core committee members take charge of their responsibilities on a rotational basis so that all members in the committee get an opportunity to lead. The survivor's forum has become an independent department this year with budgets allocated.

The main activities of the forum are:

- Providing counselling to new victims admitted in Emergency shelter and orienting the new victims on their entitlements from the Government.
- Identifying and supporting survivors who need emergency financial support
- Lead the reception committee for any guest orientation and exposure
- Organize events and programs
- Follow up survivors who are reintegrated and connect them for appropriate support.
- Provide restored survivors immediate support through restoration unit

This year apart from all the activities the survivor's forum facilitated the funeral of three survivors and also reached out to survivors who were badly effected due to Covid pandemic.

VICTIM-CENTERED ADVOCACY

Capacity Building of Duty Bearers for Preventing and Combating Trafficking in Persons

Between January 2017- January 2020, a project titled “Combating TIP through Victim Centred Approaches in India”, was implemented with the overall goal to reduce human trafficking in India. Prajwala, together with the Catholic Relief Services, and with the support of the US State Department successfully implemented this project in four states of Telangana, Andhra Pradesh, Odisha, and Jharkhand with the dual objectives of (a) Increasing successful victim-centred investigations and prosecutions and (b) Improving comprehensive services for victims.

Despite its far-reaching impact, law enforcement and victim identification efforts in India continue to remain limited compared to the scale of the problem. Lack of awareness among lower-level law enforcement and judicial officers is one of the major factors preventing prosecution and conviction for human trafficking crimes.

In this backdrop and taking forward the learnings from the JTIP project, in September 2020, Prajwala with the support of the US Consulate General, Hyderabad started a Project titled “Capacity Building of Duty Bearers for Preventing and Combating TIP”, being implemented in Andhra Pradesh, Telangana and Odisha for a duration of 12 months.

The key project objectives are to: (a) develop ready-to-use Handbooks to assist all the relevant duty bearers i.e., Judicial Officers, Prosecutors, CWC, Labour Officers and CSOs to understand the law, their respective roles and responsibilities within this and also those played by other related stake holders and (b) develop and execute training workshops to build the capacity of district-level officers to apply the skills outlined in the Handbooks.

In light of the prevailing COVID 19 environment, activities were such envisaged that may be operationalised effectively through the medium of on-line platforms and remote connectivity.

Project Achievements: These Handbooks, designed to assist members of five groups of duty bearers – Judicial Officers, Prosecuting Officers, Child Welfare Committees, Labour Officers and Civil Society Organisations, represent a unique effort by Prajwala to collate existing laws, policies and judgements that empower duty-bearers to effectively deal with cases of human trafficking, while keeping the victim at the centre of focus. The process spanning over a period of 5 months entailed extensive research, dialogue and coordination with varied stakeholders ranging from the civil society and government counterparts, resulting in the development of 15 Handbooks (set of 5 for each state). During this time, Dr. Krishnan also personally coordinated with the respective representatives of the duty bearers of the three states i.e., the Hon’ble Governor’s; Director of Prosecutions; Secretaries, Women and Child Development; the Labour Commissioner’s and Civil Society Representatives, for their Foreword’s to be included in the Handbook’s. In this context, while initially it was planned to have the release of the Handbook’s to be done by the respective Chief Justice of the States, it was decided that it would be more prudent to have the release done by the respective State Governor’s, as a more neutral state body.



RELEASE OF HANDBOOKS

Following intensive consultations by Dr. Krishnan, the **Hon'ble Governor of Odisha**, Prof. Ganeshi Lal, consented to release the same at the Raj Bhavan on 24th February, 2020, in the presence of the respective representatives from the Duty Bearers and the project partners.



Governor of AP, His Excellency Shri. Biswa Bhusan Harichandan, released the Handbooks, on 8th April at his Office, in the presence of Padmashree Sunitha Krishnan, Founder & General Secretary, Prajwala. Due to COVID restrictions, this was not a public event.





ROLL-OUT OF DISTRICT TRAININGS

The roll-out of district level trainings for the respective states began in March 2021 and is expected to be completed by October, 2021, covering the entire length and breadth of the 3 states and moreover, in the process, institutionalising the Handbooks in the states, thus taking it beyond the life term of the project cycle.

ADVOCACY

The covid Pandemic compromised the advocacy efforts in a very big way as the year mostly was dedicated to dealing with crises that pandemic had triggered. The main efforts taken this year:

Legal Advocacy: A Public Interest Litigation was filed in the High Court of Telangana for extension of lock down as a means of public safety. While the PIL was rejected on the grounds that it was public policy matter of the government it did create a lot of ripples in the Government to review the lockdown. The other pending case in the High Court for Telangana for the establishment of Child Welfare Committee was successful in ensuring 30 new Child Welfare Committees in all the districts of Telangana. This achievement was after 2years of struggle in the High Court.

Policy Advocacy: A lot of efforts was put in virtually to bring in policy level changes. Sunitha Krishnan, Founder, General Secretary assisted the Government in framing the rules for the Juvenile Justice Act. As a part of the core committee the rules were framed and has been forwarded for Government approval.

The plight of transgenders witnessed during the lockdowns motivated the organization to recommend for a comprehensive policy for transgenders. The organization drafted a policy and has submitted it to the Chief Secretary. The organization was also responsible for setting up a Transgender Desk at Cyberabad Commissionerate.

Resource persons from the organization conducted several virtual sessions to bring in policy changes.

Media Advocacy: The use of social media was amplified during the pandemic for the purposes of advocacy. An entire series on survivor centric advocacy efforts was kick-started on the 30th July, 2020, The World day Against Trafficking in Persons. This event which brought former Supreme Justice Madan B Lokur, Supreme Court Advocate Aparna Bhat, Activist Ravikant, Psychiatrist Achal Bhagat together with 100 survivors from all over South Asia. Survivors moderated the session with the experts and created a platform for an open understanding on the issues of human trafficking. This was followed with a web series of six episodes titled #RealityCheck as a part of #EndHumanTraffickingSeries moderated by Sunitha Krishnan and Salil Kader from US Consulate of Hyderabad. Each episode brought together stakeholders such as judicial officers, prosecutors, civil society organizations, political leaders and police officers. This social media series was touted as one of the best efforts in sensitizing on human trafficking issues.

Cyberabad cops set up first transgender desk

IN a first of its kind initiative in Telangana, the Cyberabad police has set up a 'transgender desk' at the commissionerate to address concerns of the community, while creating an interface for transgender persons to access job opportunities, education, and other basic rights.

Speaking on the occasion, Cyberabad CP VC Sajjanar requested that all departments to co-operate and coordinate in preventing human trafficking. He further said that to prevent human trafficking, a special unit has been set up in Cyberabad on September 5, 2020. So far, the unit registered 11 cases and arrested 54 culprits and rescued 23 women and children who were victims of such cases.

In Cyberabad special anti-human trafficking unit will co-ordinate with concerned departments to provide immediate assistance to the victims. He also said that a dedicated officer would monitor the pending trial cases of human trafficking. The Anti-Human Trafficking Unit will coordinate with all the officials of various departments in preventing Human Trafficking. AHTU Officer-in-Charge K. A. Sajjanar along with AHTU team and officials from various departments were present at this meeting.

COVID PANDEMIC RESPONSES

When Covid19 struck the world the jolt was felt everywhere including Prajwala interventions to combat trafficking. The economic devastation that followed the lockdown combined with the largest humanitarian crises of migrants fleeing to their states and the radical penetration of the virtual world not only accelerated human trafficking but also brought in strengthened versions of cyber trafficking impacting the lives of thousands of children. During these dark phases when significant part of the world moved out of the physical domain and preferred virtual engagement Prajwala chose to make use of each of these adverse situations as an opportunity to respond against human trafficking. The following measures were taken during the period of 2020.

COVID RELIEF: Responding to the unfolding disaster, relief operations were organized to ensure communities do not starve and even the most excluded would get all support.

Daily packed meals were distributed to 10,000 migrant workers who were fleeing the state by foot. 5000 Transgenders, rag pickers, survivors of trafficking and refugees were provided two months groceries. 35,000 reusable face masks stitched by survivors of trafficking was donated to Health Department for all the front-liners.

CAPACITY BUILDING OF STAFF: As most of the staff at Prajwala are field workers and are front-liners in the community they were technically disadvantaged and had poor skills to work online. As an intensive program spread over two months, staff were trained to use the online medium. Trial runs were made using zoom, skype, google meet up, Go To Meeting & other meeting Apps with all the staff. In two months 160 of the 185 staff were trained on how to use the online platforms. The time was also utilized to train staff on various topics including the legislations related to trafficking, cyber-trafficking and legal compliances.

INTERNAL STRUCTUAL & POLICY CHANGES: In order to directly respond to Covid situation a quarantine facility was established in the shelter to receive all the newly rescued victims. The 20 bedded quarantine facility was critical in continuing the rescue operations even during the Covid pandemic. When the staff on frontline duties got infected with Covid, the organization was forced to set up a Covid Hospital for the care & protection of such staff. A Covid Protocol was also drawn taking into consideration the mobility restrictions and potential risk to exposure.

ANTI HUMAN TRAFFICKING INTERVENTIONS:

- **Training Manuals:** Three comprehensive training manuals on human trafficking for Anganwadi Workers (Frontline Community Workers of the Government), Demand Reduction and Community Vigilant Group was prepared to standardize the capacity building training of all stakeholders.
- **Anganwadi Workers Training:** 892 Anganwadi workers were trained using the Training manual. The initial training for 300 workers was done on zoom which was then followed by two days physical training with all Covid Protocols
- **Training on Demand Reduction:** 50 men were trained using the Demand Reduction Manual physically in three batches.
- **Virtual Anti Trafficking Series:** #RealityCheck a virtual series was started to sensitize duty bearers and stakeholders on human trafficking. The series covered hundreds of judicial officers, prosecuting officers, legal experts, civil society organizations, parliamentarians and survivors of trafficking. The Series which was conducted on zoom was telecasted live on Facebook and thereafter the videos were posted on Youtube. 500 judicial officers, 500 prosecuting officers, 40 civil society organization and

100 survivors of trafficking participated from 14 states and two countries. 38,000 joined Facebook to view the series.

- **Rescue Operations:** 120 women and girls were rescued during the pandemic and were provided all support for rehabilitation.

All Prajwala Operations became full-fledged physically from November, 2020.

COVID RELIEF









ADMINISTRATION HEAD OFFICE



Any organization's basis to function smoothly is a good HR administration and an efficient finance team as its backbone. Prajwala promises both so that the day to day management of activities by various interventions is carried out effectively.

ADMINISTRATION – HEAD OFFICE

The Administration at Head Office looks after overall HR related work, maintenance of the campus, organic farming and security. The primary function of the administration team is to look into appointments, interviews, promotions, terminations and other related work as per management directions and a department's requirement. It provides vehicular support for interventions during programs, for emergency services like medical for ES or legal to travel to court and/or daily transportation for its staff. It supports visitors' accommodation and other requirements if necessary. The security services have been now handed over to Rudraksha Security Agency Pvt Ltd. ensuring the safety and protection of ES residents and staff. Eco management and organic farming are also other major activities of the administration team, which ensures that all vegetables and fruits are grown organically with minimal fertilizer use. There are bio gas plants, which recycle waste. The team ensures that electricity, water supply and lighting are all properly working.

Administrative Department of Prajwala holds the distinctive responsibility of holding all the programs and operations of the organization together. The department has several central roles that are key to the smooth functioning of the shelters, learning centers, production, training. It is directly responsible for effective implementation of the organizational policies viz., HR Policy, Procurement Policy, Warehousing Policy, etc. It is essentially the backbone of the organization and carries out its responsibilities with great diligence

The primary function of administration team is look into Human resources (Recruitment, terminations, Orientation of policies, Transfers) and Campus Maintenance (STP, Generator, Biogas, Solar) and general administration such as requisitions, advances and settlements and other related work as per management directions and a department's requirement. The team ensures that electricity, water supply and lighting are all properly working well.

- **Lock down activities:** During the lockdown phase the work from home tasks done by the team included masks stitching, introduction to social media, Covid relief and virtual sessions on administration related subjects. The team self-financed grocery kits and distributed in their immediate neighbourhood each adopting five families.
- **Staff Welfare**
 - Medical Insurance:** As a staff welfare initiative medical insurance was introduced this year. This was a critical support as many staff were Covid infected and needed this much required support.
 - Provident Fund:** For the first time in the organization, provident fund was introduced. This was a long pending need of the staff which was finally fulfilled.
- **Prajwala For Humanity celebrations:** As a part of the larger team the administration team played a key role in the Navaratri Celebrations which was this year themed as 'Prajwala For Humanity'. The nine days were celebrated by acknowledging the effort of supporters and honouring their work.
