ABOUT PRAJWALA

Established in Hyderabad in 1996, Prajwala is a leading Indian non-governmental organization (NGO) dedicated to the eradication of sex trafficking and associated crimes against women and children. Founded by the Dr. Sunitha Krishnan (Padma Shri awardee) and late Brother Jose Vetticatil, the organization's genesis arose from the eviction of Hyderabad's red-light district. Their initial response was to establish an educational program for the vulnerable children of women in prostitution, thus pre-empting intergenerational exploitation.

Prajwala has since evolved a comprehensive strategy that involves prevention, rescue, rehabilitation, reintegration, and advocacy. The organization has developed and implemented innovative interventions such as safe homes that provide holistic rehabilitation, demand reduction programs Men Against Demand, community awareness campaigns Swaraksha, one-stop crisis centers, and training manuals on victim-centric investigation and care. These initiatives are now recognized as best practices on a global scale.

Prajwala's impactful legal advocacy has influenced national policy. Their efforts led to the Government of India drafting the country's first comprehensive anti-trafficking legislation, a historic bill now awaiting parliamentary introduction. Prajwala played a leading role in establishing the country's cybercrime portal for reporting instances of rape/gang rape videos, child sexual abuse material and drafting the first ever national plan of action against cyber enabled human trafficking.

Having successfully rescued over 28,200 women and children from the clutches of sex slavery and facilitated the rehabilitation of 26,500 individuals, Prajwala stands as a path-breaking organization in the anti-trafficking domain. It has been recognized as a powerful voice for the millions still enslaved, paving the way for alternative solutions and a future free from this modern-day scourge.

Vision

Eradicate sex slavery and commercial sexual exploitation in all forms.

Mission

Prajwala believes that the worst form of human rights violation is sex trafficking and the oldest form of sexual slavery is flesh trade. The numerous actions and efforts taken by Prajwala are aimed at mitigating root causes of trafficking and restoring the dignity to victims of commercial sexual exploitation with reintegration as the end goal.

Goal

Establishing holistic field practices for comprehensive victim services and advocating for its nationwide replication and lobbying for laws and policies to achieve the larger goal of combating sex trafficking through a collaborative partnership model.

Journey So Far

Prajwala has completed 27 years of unwavering dedication in the fight against sex trafficking and sex crimes. Driven by a shared commitment to end sex slavery and sexual exploitation, the organization has become a best practice model in providing services for the prevention and rehabilitation of women and children rescued from commercial sexual exploitation. During the financial year 2022-2023, a team of 202 committed staff, including both professionals and field workers, have managed all interventions of Prajwala, with 50% of them being survivors themselves. The rest of the team comprises dedicated professionals from diverse backgrounds, including individuals with postgraduate degrees in management and social work. It is the dedication and commitment of this team that makes Prajwala a successful needs-based organization. Prajwala also benefits from a small but highly committed group of volunteers who have dedicated their skills to this mission.

Prajwala's Interventions

Over its 27 years of service, Prajwala has developed a comprehensive set of interventions that address sex trafficking and sex crimes in a holistic manner and believes in experimenting with different approaches to tackle the problem, implementing evidence-based solutions, and advocating with state and non-state partners to replicate or adapt these strategies.

It is one of the few pioneering organizations in the world that has tackled the issue from all angles with considerable success, focusing on prevention, rescue, rehabilitation, restoration, and reintegration—the five pillars of the organization.

PREVENTION

1. PREVENTION

Although illegal, human trafficking for commercial sexual exploitation continues to thrive in India. Women and children continue to be vulnerable to trafficking. Traffickers are recruiting women and girls both locally and online for sexual exploitation. Children, in particular, have been vulnerable, being trafficked for sexual purposes, forced marriages, forced begging, and forced criminality.

In this context, Prajwala has persevered with unwavering determination to prevent human trafficking. Disrupting trafficking safely requires building the resilience and awareness of communities and empowering vulnerable individuals as well as the wider community.

The three major prevention strategies are:

- Prevention through vocationalised education
- Community based prevention programmes
- Demand Reduction – Vikalp Centres

1.1. Prevention through Vocationalised Educational Program

Prajwala started working with the children of women in prostitution in the Old city soon after the evacuation of Mehboob-ki-Mehendi in 1996 to prevent inter-generational entry into prostitution. Now the space has expanded to a wide range of vulnerable children and their mothers to protect them from the environment they live in.

Goal: Prevent second generation and inter-generational prostitution through the provision of education and vocational skills.

Objectives :

- Provide holistic education through educational center and open school for vulnerable children who could be potential victims of prostitution.
- Provide vocational skills and access to sustainable employment for vulnerable young adults.
- Foster community participation in the implementation of the intervention

In order to achieve the above objectives, Prajwala has Learning Centres that include an educational centre, an open school and a vocational centre. There are seven such Learning Centres located in different areas in the Old City of Hyderabad. Each Learning Centre has qualified and committed staff members who work with the students and the community members to counter the vulnerabilities of their social and economic background. Admissions to the different programmes in the Centre is decided by a Scrutiny Committee comprising of community members and teachers. During the year, four Scrutiny Committee were conducted, and new admissions were identified for the different programmes.

Educational Centre which caters to children from class 3 to 6, aged 8 to 14, belonging to severely impoverished background not having any family support and care and who are vulnerable to be sex trafficked. The objective is to provide these children access to education and prepare them for mainstream schools. Education in English, Urdu, Hindi, Telugu, Mathematics, Science, Social studies is provided by qualified teachers with emphasis on personality development, self- motivation and equal opportunity through planned activities. Every year children who are prepared are admitted to regular private or government schools. The organization supports the fees and educational material of these students till they complete graduation.

Open School targets young adults – aged 14 and above, mainly girls, who are at highest risk of being trafficked. They are school dropouts who belong to vulnerable families and include young adults who may be orphans, step daughters, single parent, disabled, economically backward and children of prostitutes. The objective is to ensure that these vulnerable school dropouts get back to the education fold by helping them prepare for high school exams and connect them to the option of 'open school' Qualified teachers bring these children up to the level of 10th standard so that they can appear and clear the 10th board exam, thereby opening avenues for higher education.

Vocational Centre targets young adults aged 16 and above who have completed or are completing their basic education and are at high risk of being trafficked due to their family background or personal financial condition. The objective is to skill the youth in alternate livelihood options so that they can earn a living through dignified jobs. Qualified skill development partners conduct time based programs for skills training on different vocational skills and provide access to job placement to youth who have completed the training successfully. During the year, young persons were trained in Mobile Repair and Service, making of Jute Products, Dress Designing, Bangle Making.

Key Highlights:

- 13 students who are covid orphans/semi orphans received educational support of 3,20,000/-
- 163 community mothers were trained through Employability training unit on job skills out of which 69 mothers are employed in different companies and offices after ETU training and 63 members are motivated for self-employment and 6 members received self-employment support from management through employability training unit
- 42 staff members participated in a 10-days Residential teacher training program that was held in collaboration with Silver Oaks International School, 42 staff were equipped with new teaching and learning strategies.
- Leadership Skills programme was conducted in all Learning Centres for the students.
- Science Fairs were organised in all Learning Centres that were attended by students, parents, community members and even students from mainstream schools.
- During the Ramzan month, all Learning Centres organised iftar parties and also distributed provisions to 60 very poor families who were selected by the students of the centres.

- During this period, the learning centres received various items as in-kind donations following committee meetings. The donations included 9 mats, 7 stools, 4 fans, 4 pots, 2 carpets, 4 chairs, 1 iron box, 1 shoe stand, 1 green mat, and 50 notebooks. The total value of these donations is Rs. 1,70,031/-.
- Learning Centre Management Committees have been set up at 6 Learning Centres with community members taking responsibility for the management of the Centre. A bank account has been opened for each Centre with a community member as one of signatories. An amount of 6,15,960/- Rupees was received as community contributions from mothers and community members towards the corpus for implementing some of the centre's activities.

1.2. Community Based Prevention Program

Prajwala's Community Based Prevention intervention uses mass anti sex trafficking sensitization programs, campaigns and rallies to awaken the community (boys and men above 14 years) in a concerted effort to reduce demand and end the supply for prostitution. The team partners with local community members, police department officials and district administration to raise awareness about sexual crimes and sexual slavery. It also empowers individuals to take ownership of their local community to become more responsible, informed and vigilant citizens through the formation of Community Vigilance Groups (CVGs).

Goal: Prevent trafficking at source - both demand and supply

Objectives:

- Empower young & vulnerable girls with the knowledge of sex trafficking and tactics used by traffickers so as to prevent them from being trafficked.
- Awaken communities on the consequences of trafficking and generate support to curb trafficking in their region.
- Awaken men on the impact of trafficking on women and generate support from them to curb demand for paid sex.
- Create community vigilant groups who can be the voice of anti-trafficking in the communities.

Programmes:

The School and Hostel Programs target school children from Classes 7-10, who come from under-privileged and impoverished families and are highly vulnerable to being trafficked or married off early. This is conducted in government schools and residential educational institutions.

The Village /Slum Programs target rural and urban poor communities mostly the supply area and focuses on parents, community members, men, women and young adults. This is conducted in slums, hamlets and villages with a population of around 5000 in Andhra Pradesh and Telangana. During the year, Prajwala conducted training programmes with frontline workers including Anganwadi workers and Village Organisation Assistants from the District Rural Development Agency. Smt. Dhana Laxmi, an Anganwadi teacher, conducted four awareness programs for Self Help Group members, reaching a total of 104 participants.

Ms. Jhansi, a member of the Community Vigilant Group (CVG), encountered a minor girl named Seelam Pawani during a bus journey. Pawani, aged 16 and from Kodad, was traveling to Vizag in search of a job due to familial discord. Previously, she had faced parental objection to a romantic relationship during her 9th grade, which strained her relationship with her family. Despite pursuing studies in Polytechnic, she decided to leave home without informing her family.

Sensing that something was amiss, Ms. Jhansi engaged with her, learned about her circumstances, and promptly contacted the CBPP team from Prajwala, who specialize in human trafficking prevention. The team provided counselling and assistance and with coordinated efforts, Pawani was reunited with her family safely, avoiding the risk of trafficking. This case exemplifies the positive impact of community-based prevention programs in safeguarding vulnerable individuals like Pawani.

The Anti Demand Campaigns target men and young boys who constitute demand for paid sex. This is conducted in schools, colleges, auto rickshaw stands, auto drivers unions, truck drivers associations, men's clubs, etc. The Demand Reduction Trainings were conducted through 29 programs with a total of 2,376 members. 28 Community Vigilant Groups (CVGs) were formed, comprising a total of 807 members. These CVGs conducted 17 programs with 311 participants.

1.3. Demand Reduction Program - Vikalp

“Vikalp” aims to end demand for paid sex to combat trafficking. Its objective is to engage with male buyers of paid sex and provide them three-tiered counselling for behaviour modification.

In an attempt to reduce the demand, the organization in collaboration with police attempt to identify the vulnerable places with regard to street prostitution, conduct decoy operation to find out the sex buyers and counsel them. The main objective of this counselling is to change the attitude of women in prostitution and mind set of males buying sex, through different strategies and techniques so that there will be very less or no demand for paid sex in and around vulnerable places.

For this to happen, the organisation seeks help from trained counsellors, family members and faith leaders who can bring in a positive change in the very attitude of sex buyers.

The following steps are followed while counselling:

- Step-1:** Counsellors understanding the profile of the sex offender and then offer them counselling
- Step-2:** Showing documentary films like “Mein Aur Mere Sachhayee”
- Step-3:** Provide counselling for and with family members
- Step-4:** Faith leaders to further counsel the sex buyers.

Highlights of the year

- During this period, the police team apprehended 219 sex buyers and provided counselling to each of them. Additionally, petty cases were registered against all 219 individuals.
- Follow-ups were conducted with 425 old and new sex buyers, and second counselling sessions were provided to them.
- On August 1st, 2023, a new counselling center named Vikalp was established at Meerpet police station in the LB Nagar zone and inaugurated by Sri Anjani Kumar, DGP of Telangana Police, Padmashri Dr. Sunitha Krishnan, founder of Prajwala, Sri D S Chauhan, Commissioner of Police Rachakonda, and Sri Sai Sree, DCP of LB Nagar Zone.
- 103 transgenders visited the Vikalp centre and received various services: 4 received employment assistance, 6 received support for self-

employment, 42 obtained Aadhaar cards, 11 received transgender certificates, and 2 obtained voter IDs.

- A meeting was held with 150 transgender individuals at Kanakadurga Function Hall and the Vikalp team explained the services offered by Vikalp during the meeting.
- Successfully motivated and counselled 6 transgenders, leading them to cease begging and initiate self-employment ventures with support from Vikalp (Prajwala).
- Three awareness programs on reducing street prostitution demand and combating human trafficking were conducted in LB Nagar Zone. These programs were organized in collaboration with the Community Based Prevention Program-Prajwala.

2. RESCUE

Despite the determined efforts to prevent sex trafficking, a significant number of women and girls are trafficked and are subjected to endless cruelty, physical harm and emotional trauma. Removal of the victim from the place of exploitation becomes crucial. Prajwala's Rescue and Restoration team works closely with all stakeholders to facilitate the rescue of victims of sex trafficking and sex crime as well as repatriation, reintegration with family and community and the provision of post rescue support such as legal aid, recovery of belongings. At the operational level the team supports the local police and the Anti-Human Trafficking Unit to conduct the actual rescue operations.

Prajwala's rescue program has three main interventions:

- Planned rescue operations
- Rape Victim Support Program
- Victim Witness Protection

2.1. Planned Rescue Operations

Prajwala supports the police in a rescue operation by identifying and providing assistance in the place of exploitation while the police look at the crime and the criminal.

While most victims of sex trafficking are rescued from brothels or place of exploitation which could be a house, lodge, hotel, resort, massage parlour, beauty parlour, in the case of minor victims of sex crime, they are moved to a place of safety only when there is clear threat perception as expressed by parent or guardian or the parent or guardian themselves are perpetrators. Prajwala provides support during the court proceedings and the safe custody of the victim of sex trafficking once a court order has been provided. If the victim is a minor, then she is produced before the Child Welfare Committee (CWC) which is the legally competent body to take decisions about children. No victim is shifted to safe custody without the orders of a legally competent body such as the court or the CWC. Prajwala removes adult and child victims from the places of commercial sexual exploitation and child victims of sex crime when there is a situation of threat perception.

Key Results

This year a total of 254 adults and 04 minor victims were rescued from sex trafficking and sex crime. Among them several of them were from other countries. All rescues were conducted along with the Police Department.

ACCUSED GOT 3 YEARS IMPRISONMENT CONVICTION IN PROSTITUTION CASE

(Capital Information)

Hyderabad, May 19: The facts of the case are that, on 17-03-2013 at 2000 hours Kushaga Police received a credible information regarding running of online brothel business by using Locanto Application by accused A1 Sai who is a main organizer with help of A2 Matturi Vamshikrishna on which Sri B. Sreenu SIP along with Police staff conducted a decoy operation at Eshwaripuri Colony, Sainikpuri where A1 who brought two women victims for indulging online prostitution through male customers on observing Police accused A1 fled away from the scene and apprehended A2 and two women victims. Basing on the above complaint a case was registered at Kushaga PS.

During the course of investigation, IO collected the evidence and arrested the accused and sent to judicial custody. During the trial today i.e., 19.05.2023 the Hon'ble P1 Senior Civil Judge cum Adst Sessions Judge at Malkajgiri convicted the accused Matturi Vamsikrishna S/o M.Narsimha Rao, Age 25 Yrs Occ PVT Employee R/o Vijayawada to undergo 3 Years Rigorous Imprisonment R/o Vijayawada and imposed fine of Rs. 1000/- . In this case the IO A.Mannohan Now SHO Abdullapuram PS, Adl. Ppt. Smt. Nirmala, CDO P.Narsimha PC 4676, Summons G.Balakrishna PC 10783 of Kushaiguda PS have attended on behalf of prosecution.

CP Rachakonda D S Chauhan IPS., and Joint CP V. Satyanarayana IPS., appreciated the IO, CDO and Addl.PP for their efforts in getting the conviction to the accused persons and announced rewards to them.

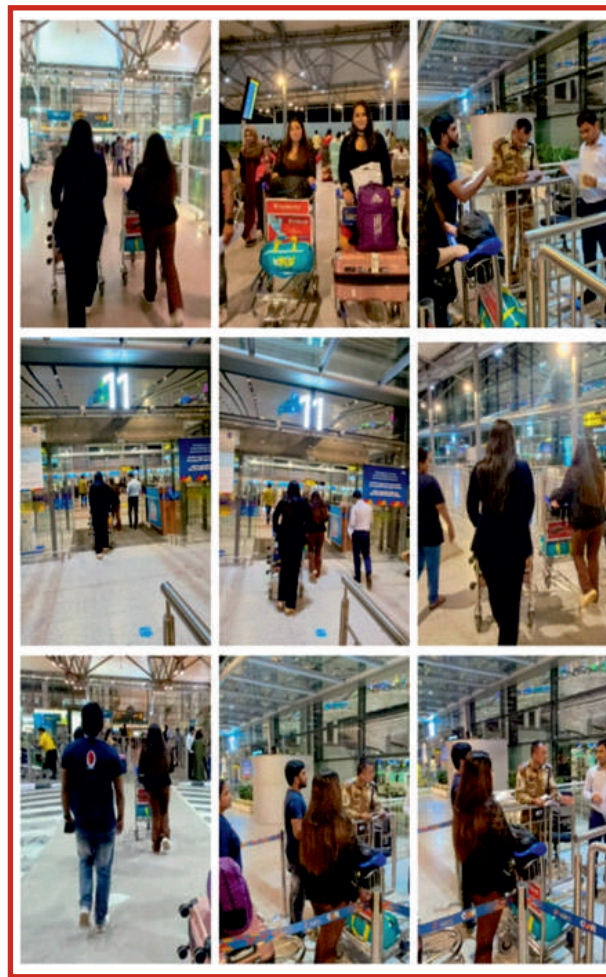

2.2. Rape Victim Support Program

The Rape Victim Support Program is specially designed to offer support for minor victims of sex crimes. With the overall objective to provide holistic care to a minor victim of a sex crime and ensuring victim witness protection and social integration, the program aims to provide:

- Emergency trauma care support to minor victim and her family
- Safe home for victims facing threat perception
- Facilitate effective prosecution and compensation

While most victims of sex trafficking are rescued from brothels or place of exploitation which could be a house, lodge, hotel, resort, massage parlour, beauty parlour, in the case of minor victims of sex crime, they are moved to a place of safety only when there is clear threat perception as expressed by parent or guardian or the parent or guardian themselves are perpetrators. Prajwala provides support during the court proceedings and the safe custody of the victim of sex trafficking once a court order has been provided. If the victim is a minor, then she is produced before the Child Welfare Committee (CWC) which is the legally competent body to take decisions about children. No victim is shifted to safe custody without the orders of a legally competent body such as the court or the CWC. Prajwala removes adult and child victims from the places of commercial sexual exploitation and child victims of sex crime when there is a situation of threat perception.

2.3. Victim Witness Protection

The Victim Witness Protection programme aims to ensure victim witnesses have a safe and non-threatening environment in their journey for access to justice. The support includes

- (1) Legal support to record initial statements in court, identify the accused and prepare them for final trial.
- (2) Recover all belongings including children from the place of exploitation
- (3) Connect to all entitlements including financial relief and compensation.

REHABILITATION

3. REHABILITATION

While rescue operations are swift and time-bound, rehabilitation is a prolonged process that demands considerable time and effort. A trauma-informed rehabilitation initiative encompasses three phases, each defining specific responses:

- **First Response:** This phase lasts for one month from the time the victim is removed from the place of exploitation. During this period, the victim experiences absolute confusion and distrust. Although the internalized behavior due to trauma may not be acutely visible, maladaptive coping mechanisms such as aggressive behavior, lack of trust, and attachment to the abuser are most prominent. This phase often includes withdrawal symptoms from substance abuse or alcoholism. The primary focus during the first response is on trauma counseling and appropriate healthcare. As this is the trust-building stage, survivor advocates and peer counselors play a crucial role in helping the victim her rights and connecting her to legal assistance. Legal protocols are completed, and basic life-skills and employability skills are provided. The Emergency Shelter offers first response support.
- **Long-term Rehabilitation:** At the end of the first response, a rescued person begins to identify herself as a victim and comprehend the specific exploitation she endured. During this stage, concrete support is extended, including psycho-social interventions, advanced life-skills, education, livelihood training, employment options, and access to victim assistance such as immediate relief and compensation. The Children's Home (Astha Nivas) and the Adult Home (Ashaniketan) provide long-term rehabilitation services.
- **Community-based Rehabilitation:** As the victim progresses to become a survivor and is ready to reintegrate into society, she needs a support system to help her navigate social stigma and ostracization. This support is especially critical if the family is unwilling to accept her, necessitating an independent start to her new life. Community-based rehabilitation aims to support the survivor integrating smoothly into a life of dignity. This includes need-based counseling, family interactions, access to employment or self-employment, after-care support, and a safety net such as being part of a survivor network. The After Care Home and the Survivor's Network provide community-based rehabilitation.

3.1. Shelter Programme

All three shelters - the Emergency Shelter, Astha Nivas (Children's Shelter) and Ashaniketan (Adult Shelter) - operate under common standards of care to ensure the emotional, psychological and medical well-being of the residents.

Emergency Shelter is where the victim is brought in immediately from the police station. A victim stays here for any duration for 1 day to 30 days depending on the individual case. The objective of the shelter is to provide immediate emotional support through counselling and earn trust of the victim as a place she can feel safe in. Most legal formalities for evidence recording u/s 164 of IPC are conducted from this shelter. Victims are also taken to medical emergencies and any conditions of HIV, pregnancy etc are detected from this shelter. Once the victim is comfortable with living in the shelter, she is transferred to Adult or Children's shelter depending on her age.

Children's Shelter is where the child victims (below 18 years) are brought from Emergency shelter for rehabilitation and healing. Victims stay at children's shelters for any duration upto the age of 18, or until their release orders from Child Welfare Committee. The objective of the shelter is to encourage children to take up education seriously. Children are sent to the learning centre within the campus to prepare them for normal school and thereafter admitted in government and private schools

outside the shelter as well as colleges outside the shelter depending on their educational qualifications. The shelter home follows a daily routine, which includes dorm management, school and study hours for 8 hours, cleanliness and maintenance of premises all managed and monitored by the young girls. Individuals requiring medical and psychological attention are taken care of on a on-demand basis besides regular sessions for the said purposes. Some mental health patients and pregnant and lactating girls are given special attention. Parent/Gaurdian visits are facilitated based on permissions given by Child Welfare Committee on a Sunday. Special care is taken for over-all personality development and grooming through exposure trips, leadership training, student management committees.

- One victim testified against the perpetrator who was sentenced to 5 years in prison with a fine of 10,000 rupees. The victim received compensation amounting to 4,00,000 rupees. The judgment was issued by the POCSO Court in Mahabubabad district.
- Another victim received compensation of 7,00,000 rupees, and the offender (the victim's own father) was convicted and sentenced to twenty years' imprisonment. The final statement was completed at the POCSO Court in Shadnagar.
- 4 residents successfully secured convictions against their perpetrators in their respective cases.

Adult Shelter is where the adult victims (above 18 years) are brought from Emergency shelter for rehabilitation and healing. Mostly victims stay at adult shelters for any duration between 3 months to 2 years, depending on court release orders. The objective of the shelter is to provide holistic healing and long-term rehabilitation of victims through emotional and psychological healing and life skill support. Shelter home follows a daily routine, which includes dorm management, skill development, cleanliness and maintenance of premises. Individuals requiring medical and psychological attention are taken care of on an on-demand basis besides regular sessions for the said purposes. Victims/survivors are released on a court order. The court scrutinizes the Home Investigation Report and gives the final direction regarding each case.

3.2. Economic Rehabilitation

The objective of the Economic Rehabilitation programme is to prevent the re-trafficking of victims by skilling and placement of victims. Prajwala provides employability training including basic numeracy, literacy, spoken English, personality development and workplace culture and ethics, job placements and skill development/industrial training in different trades.

Economic Rehabilitation Program

The In-house Training cum Production Centre offers training in Dress Designing & Fashion Technology, Carpentry, Welding, Book binding, and Organic Farming. Based on their choice and aptitude, shelter residents receive training in these trades and secure employment either in house or outside. The training center is also a production unit and undertakes orders from major companies. **A major achievement for this year is the elevation of the Centre as a Government recognised ITI and Prajwala ITI (PITI) is now open for admissions.**

3.3. Civic Rehabilitation

Victim Centered Advocacy is a holistic approach that prioritizes the needs, rights, and well-being of the victim throughout the entire process of recovery and reintegration. This method focuses on empowering survivors by ensuring their voices are heard and their choices respected. It involves providing comprehensive support services, including legal assistance, medical care, psychological counseling, and educational and vocational training. By fostering a supportive environment, Victim Centered Advocacy helps survivors regain control over their lives, rebuild their self-esteem, and reintegrate into society with dignity. This approach also emphasizes the importance of collaboration with various stakeholders, including law enforcement, social service agencies, and community organizations, to create a network of support that addresses the multifaceted needs of victims. Ultimately, Victim Centered Advocacy seeks to transform survivors into self-reliant individuals who can lead fulfilling lives free from the shadows of their past.

As part of this, efforts are made to secure the following entitlements for the survivors:

- Bank Account, Aadhar Card, Ration Card
- Housing, Immediate Relief, Educational support
- Voter Id

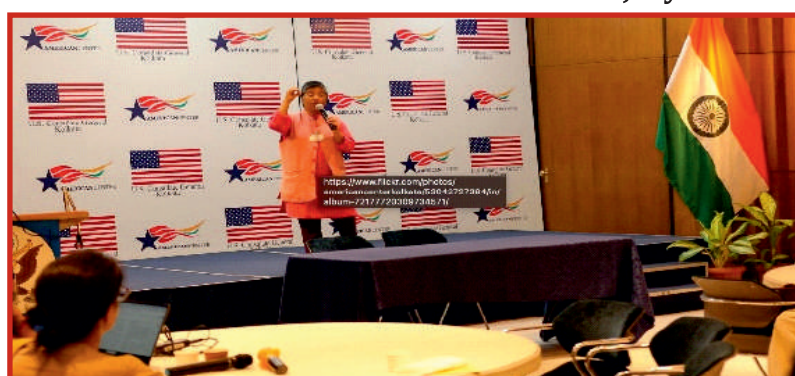

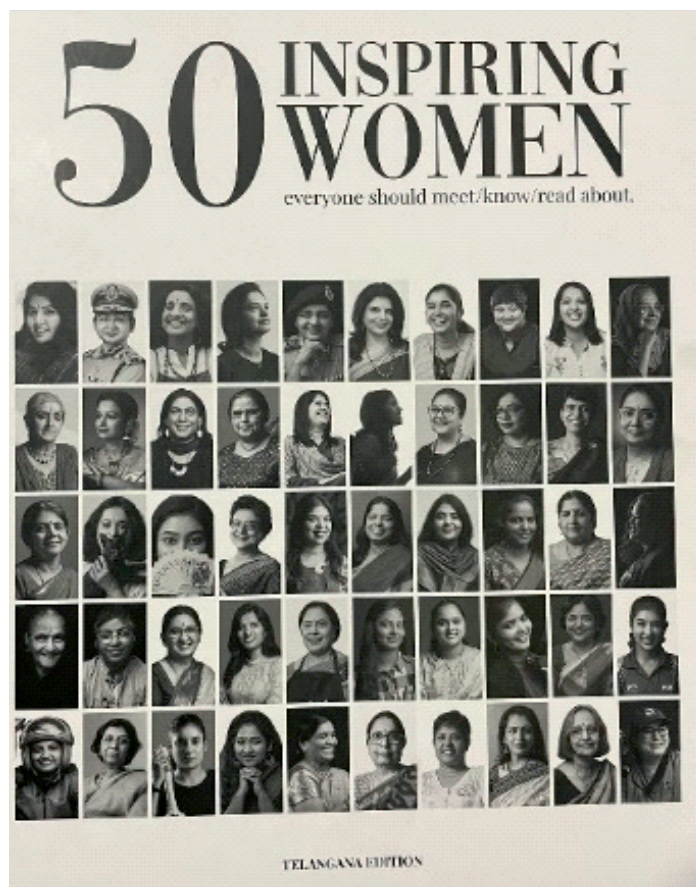
