ORDER:

The Government taking into consideration the urgent need to provide holistic care and support to victims of commercial sexual exploitation vide reference 3rd cited, have prescribed Minimum Standards of Care to be maintained by all institutions and service providers providing protective and rehabilitative facilities to such victims.

2. Accordingly, to strengthen the Government Swadhar Home (Rescue Home) for sex trafficked victims, 7 additional posts are provided for the Rescue Home at Hyderabad by redeployment/re-designation to be filled on contract/deputation basis as follows:
